### CIRCULAR

As per the decision taken in Pensioner's meeting held on 29/09/2020 it has been decided that Fresh Pensioner's Health Identity Card instructions have been issued by NAARM vide NAARM circular No. 12-322/19-Admn. (Health Card) dated 5<sup>th</sup> September, 2020 to all the ICAR institutes at Hyderabad in the scenario of Covid 19 in which any physical movement of files or papers from Institute to others is not possible. It was discussed in the recently held 9<sup>th</sup> pensioners meeting that new and fresh cards will be issued by respective institute. The Pensioner's Health Identity Cards from other institutes (Outside Hyderabad) are dealt by the ICAR-NAARM.

Moreover, as per delegation of powers by ICAR, the powers are delegated to concerned Director and Head of Office of every institute **under CSMA Rules**. Recently vide ICAR Letter No. 38(9)/2019-Per IV dated 28<sup>th</sup> September, 2020 the ICAR has delegated the powers for recognizing 'Public and Private/Public trustee Hospitals' to the IMC of the Institute. Each institute may recognize hospitals as per their need and for availing credit facility as per ICAR Letter No. 38(9)/2019-Per IV dated 28<sup>th</sup> September, 2020 (one more letter issued with same number and same date by Mr.MK Jain, Director (Special Duty), ICAR Head Quarter.

In view of the above, henceforth Pensioner's Health Cards may be issued at the respective Institutes.
