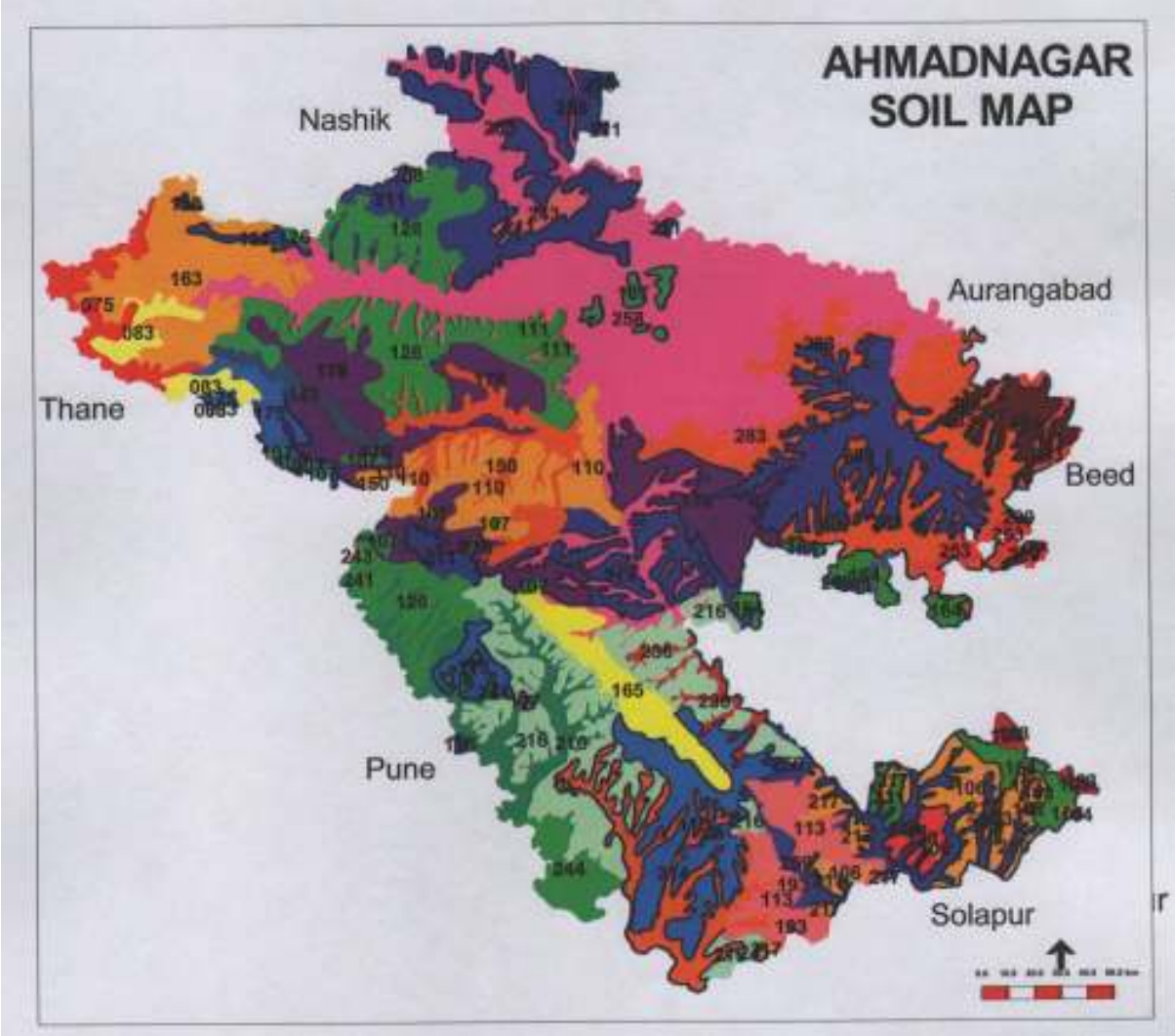

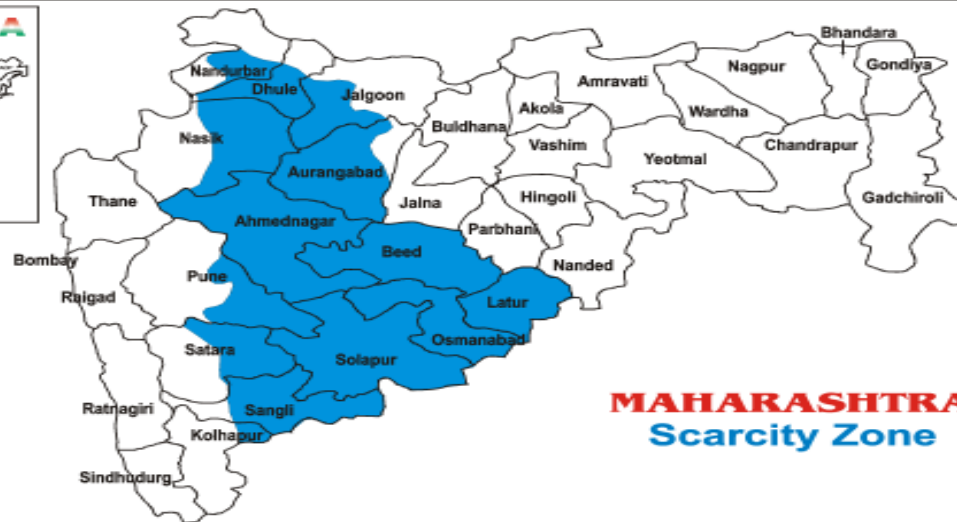


# AHMADNAGAR SOIL MAP
