General Instructions:

1. The positions are purely temporary and co-terminus with the project.
2. Eligible candidates may report for the Written Test/Walk-in-Interview by **1000 Hrs on 21.07.2026 (Tuesday)** at ICAR-CRIDA, Santoshnagar, Hyderabad – 500059. Candidates reporting after 1000 Hrs shall not be permitted to appear for the selection process. If required, a preliminary screening test (MCQs based) may be conducted for shortlisting, followed by the interview on the same day. Final selection shall be based on interview performance.
3. **Age limit:** Minimum 21 years and maximum 45 years, with relaxation as per rules.
4. Candidates possessing the prescribed essential qualifications mentioned as above shall **only** be considered. They should bring the duly filled-in application form (enclosed) along with one set of self-attested copies of certificates relating to age, educational qualifications, experience, etc. The date of interview shall be the crucial date for determining eligibility with respect to age and educational qualifications.
5. All original certificates shall be produced for verification at the time of interview. Only original degree certificate or provisional degree certificate shall be accepted as proof of completion of the prescribed qualification. Candidates awaiting results of the final examination for the prescribed qualification are not eligible to apply. Failure to produce the required original certificates (matriculation – marksheet & certificate, intermediate – marksheet & certificate, graduation – marksheet & certificate) shall render the candidature liable for rejection.
6. No TA/DA will be paid for attending the interview.
7. The Director, CRIDA shall have the final discretion in all matters relating to the selection process, and the decision shall be final and binding on all applicants.
