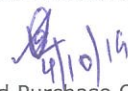
On behalf of the Director, ICAR-CRIDA invites **e-Tenders** under Two Bid System (Technical and Financial separately) for **Supply of sap flow meter**

TERMS & CONDITIONS

1. **Submission:** Only bids received on e-procurement portal will only be considered for opening. Manual bids shall not be accepted.
2. **Download of Tender Document:** Tender Document with full details can be downloaded from CRIDA Website (<http://www.icar-crida.res.in/>) or the Government of India, Central Public Procurement Portal (<http://www.eprocure.gov.in>) and in such cases, participation in the tender will be subject to remittance of the prescribed Bid Security along with the Technical and financial Bids (BOQ).
3. **Tender ID:** Shall be notified on the website (<http://www.icar-crida.res.in/>)
4. Suppliers who desire to participate in such tenders in future may bring it to the notice of Procuring Entity and may register in CPPP through DSC
5. The bidders should have a valid registration of the firm with GOI/any state govt.
6. This institute will not be responsible for any delay in enrollment or submission of the offer/uploading the offer on above mentioned e-procurement portal for any reason whatsoever. Hence vendors are advised to register in the e-procurement website <https://eprocure.gov.in> & enroll their Digital Signature Certificate (Class - II or above) and upload their quotations well in advance to avoid last minute problems.
7. **Bid Security:** Bid Security (**also known as Earnest Money**) is to be deposited by all the bidders except Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or registered with the Central Purchase Organization **30000/- (Rupees thirty Thousand only)** along with their bids. The bid security will be accepted in the form of Demand Draft, Fixed Deposit Receipt, Banker's cheque. The bid security is normally to remain valid for a period of forty-five days beyond the final bid validity period. Bid securities of the unsuccessful bidders shall be returned. **Original EMD must be delivered to CRIDA on or before last date /time of bid submission without which the bids will not be considered.**
8. **Performance Security:** The successful bidder is required to pay an amount equal to 10% of successful bid amount towards performance security deposit and the same will be released within one month from the date of expiry all contractual Obligations. No interest shall be paid on such Performance security deposit. Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations. The Performance Security Deposit should be in the form of Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks or payment online in an acceptable form and on which no interest will be paid.
9. **Delivery Schedule:** Unless otherwise specified, No 'part supply' is allowed. Specific mention should be made as to whether delivery will be from ready stock or will have to be imported / acquired and in the latter case the time required for delivery after purchase order is placed should be indicated clearly.
10. **Payment:** No advance payment is permissible. Payment will be made only after supply of equipment" is accepted by the indenter after successful, installation and commissioning of the equipment. Our normal payment terms are within 30 (thirty) days on receipt and acceptance of material at our site in good condition.
11. **Place of delivery:** Supply is to be done at Central Research Institute of Dry Land Agriculture, Hyderabad, Telangana.
12. **Installation:** Installation is to be done at Central Research Institute of Dry Land Agriculture, Hyderabad, Telangana.
13. **Shipment:** Supply is to be made securely packed at supplier's risk and transportation.
14. Attested copies of Document regarding registration /Certificate of incorporation of the firm issued by the appropriate government to be enclosed
15. **DSIR Certificate:** This Institute is exempted from payment of Customs charges Vide Govt. of India, Ministry of Science and Technology, Dept. of Scientific and Industrial Research, vide Letter No. **TU/V/RG-CDE (372)/2016, dated 18-10-2016 (Valid up to 31-08-2021).**
16. Manufacturer's name and country of origin of materials offered must be clearly specified. Please quote whether your organization is large scale industry or small scale industry. If you have NSIC/MSME/MSI/DGS&D Certificate, please attach it to the quotation. Mention your registration details.
17. Make, model/brand of the item shall be stated wherever applicable.
18. **Price quote:** The price quoted should be in INR only inclusive of all taxes.

19. All supplies are subject to inspection and approval before acceptance. Manufacturer/ supplier warranty certificates and manufacturer/Government approved lab test certificate shall be furnished along with the supply, wherever applicable.
20. The Director of the institute reserves the right to modify the quantity specified in this enquiry. The prices quoted should be firm till the supplies are completed. Please quote the rates in words and figures. Rates quoted should be inclusive of all transportation, installation and commissioning of the supply and any other charges. Prices quoted for free delivery at destination will be given preference. If there is no indication regarding the FOR, in the quotation, then it will be considered as FOR destinations. Price quoted should be net and valid for a minimum **120 days** from the date of opening of the quotation.
21. No part supply is accepted. Guarantee/Warranty/Expiry period should clearly indicated
22. Payment of GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotations. If no indication regarding CGST/SGST is recorded in the quotation, the CGST/SGST will be considered as included
23. Delivery period required for supplying the material should be invariably specified in the quotation. Technical specification should be clearly indicated.
24. **Acceptance of tender:** Director, CRIDA reserves the right to accept or reject any/all of the tenders either in part or in full without assigning any reason thereof.
25. **Specifications:** Full specifications of the item quoted should be indicated in the tender along with illustrated pamphlets, drawings/technical broucher etc. wherever available. The supplier has to submit the compliance statement on the technical specifications in the prescribed format enclosed to this schedule.
26. **Service support and warranty:** The warranty requirement for this equipment shall be minimum of 12 months from date of satisfactory installation and commissioning. In the event of the equipment requiring any rectifications, the warranty will start from date of successful rectification.
27. If the deliveries are not maintained and due to that account Procuring Entity is forced to buy the material at your risk and cost from elsewhere, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.
28. In case your quotation is accepted and order is placed on you, the supply against the order should be made completely within the period stipulated in the order. The Government of India reserves the right to recover any loss sustained due to delayed delivery by way of penalty. Failure to supply the material within the stipulated period shall entitle Procuring Entity for the imposition of penalty without assigning any reasons @ 1/2% (half percent) of the total value of the item covered in order as penalty per day subject to a maximum of 5% (five percent) unless extension is obtained in writing from the office on valid ground before expiry of delivery period.
29. **Dispute clause:** Any dispute relating to the enquiry shall be subject to the jurisdiction of the court at Hyderabad only
30. Damaged items with missing accessories will not be accepted by this institute.
31. Rates once finalized will not be enhanced/reduced during the currency of the contract.
32. In case, the successful bidder shows inability at any stage, after the contract is finalized and awarded, for whatsoever reason(s), to honour the contract, the EMD/Performance security deposited would be forfeited.
33. The Director, CRIDA reserves the right to cancel the contract at any time during the currency period of the contract without giving any Reason.
34. Any Supplier found to have cheated by supplying old items/equipments and defaulted in supplying store items even on extended time limit without reasonable grounds, will be liable for blacklisting besides imposition of penalty to the tune ICAR Unit may deem fit.

Specifications for SAP flow meter

The Sap Flow Sensors/System should measure the sap flow from roots to shoot, reverse sap flow, low sap flow and zero sap flow in an effective way through varied range of tree stem diameters of timber, fruit and medicinal trees. Principle of measurement should be Heat ratio method and system should be advanced, reliable and acceptable. Sap flow meter with sensors (thermal probe), portable data logger with remote data/wireless downloading system with storage (USB /Micro SD card) and inbuilt Sap Flow tool software (windows 7, 8 and above accessible), rechargeable external batteries (DC), charger and other essential accessories required for successful installation and measurement of real time sap flow in stem and branch of trees should be supplied with the system. Portable data acquisition system (Laptop/Note pad) for onsite data loading, data retrieval, transfer and processing should be supplied. The technical brochures of the system may be submitted. Installation, Training and Demonstration at site to be provided. The rates should be quoted as per unit cost of sensor/sap flow meter including data logger and essential accessories i.e. tool kit for fixing sensors. The rates should also be quoted for additional sensors, data logger and accessories/spare parts if needed. Accordingly, the rates for extension cables and necessary accessories should also be quoted.
