**GENERAL TERMS & CONDITION FOR REGISTRATION AND SEED PRODUCTION**

1. **Download of Document:** Document with full details can be downloaded from CRIDA Website (<http://www.crida.in>) or the Government of India

3. **Submission:** Registration form with proper superscription on the cover as for "Seed production in Farmers Field for Kharif 2020-21,2021-22 and procurement of qualified seed under seed hub programme of CRIDA-KVK – Upto 500 quintals of Redgram (Pigeonpea) – PRG 176/WRG 65,93,97/MRG1004, Horsegram-CRHG-22/18R and Greengram-WGG-42/MGG351/MGG347 should be submitted in the Office of the Director, CRIDA, Santoshnagar, Hyderabad-500 059, Telangana, on or before the due date and time as given in the document.
4. The supplier should be a individual farmer and having a capacity to produce and supply foundation / certified seed of above variety with a minimum of 2 quintals or more and the area offered should be minimum of 2 acres and maximum of 10 acres for seed production. The seeds should be produced or cultivated only during kharif season for redgram and Kharif / Rabi / Summer for Greengram, Late kharif for Horsegram
5. The quality of seed should be of foundation / certified seeds duly registered with Telangana State Seed and Organic Certification Agency (TSSOCA) for certification. The costs incurred towards nominal registration costs with TSSOCA will be recovered from farmers.
6. The seed production plots offered should have irrigation facility (2-3 irrigations during vegetative, flowering and pod formation stages of crop)
7. The farmers for seed production should be from the Southern Telangana Zone covering Ranga Reddy, Nalgonda, Suryapet, Yadadri-Bhongir, Vikarabad, Medchal and Mahaboobnagar districts for the convenience of monitoring of seed production plots by the committee.
8. Foundation / Certified Seed production should be followed as per the standard package and practices of production and isolation distances (Pigeonpea:100m for foundation seed and 50m for certified seed; Greengram:5m; Horegram:5m)
9. Intercultural operation, roguing and timely intervention of plant protection need to be taken up for quality seed production.

10. Seeds should have a minimum Germination of 75%, moisture 9%, Physical Purity Minimum 98% as per the specifications acceptable to TSSOCA (Foundation as well as certified seed).
11. The raw seeds will be processed in CRIDA-KVK processing plant before deciding the final quantity for procurement.
12. The registered farmers are advised to allocate 2 to 10 acres of land for seed production in which the previous season crop must not be of different varieties of Pigeonpea / Greengram, Horsegram. The minimum procurement from each farmer will be 200 kg, however, the procurement quantity of seed will be need based and target based.
13. Farmers should follow the instructions from CRIDA-KVK and seed certification agency-TSSOCA for seed production and MOU has to be entered between CRIDA and Farmers for not violating the process of seed production during the season.
14. **Delivery Schedule:** The selected farmers are requested to deliver the produced seed either of redgram or greengram or horsegram in respective seasons Kharif / Rabi /Summer after harvesting of crop meeting the criteria of standard of the seed condition ICAR-CRIDA.
15. **Payment:** Payment will be made only after procurement and processing of seed produced in farmer field and rejected seed will be given back to the respective farmers which need to be collected by the farmers from KVK Ranga Reddy district or payment under delayed conditions and unforeseen circumstances will be released in installments.
16. **Place of Delivery:** Supply is to be done at KVK, Hayathnagar Research Farm, Central Research Institute for Dryland Agriculture, Hyderabad, Telangana.
17. **Shipment:** Supply is to be made securely packed 50 kg Gunny bags at supplier's risk and transportation
18. **Bank details for e-payment:** The bank details may be furnished along with for making e-payment to the selected farmers.
19. **Period of validity:** The registration of farmers is valid upto 2021-22 for both kharif redgram and kharif/Rabi/Summer for greengram, late kharif Horsegram
20. **Rates:** The procurement price per quintal of accepted seed supplier will be paid as per the norms of the project as fixed by CRIDA, Hyderabad.
21. **Acceptance of EOI:** Director, CRIDA reserves the right to accept or reject any of the requests either in part or in full without assigning any reason thereof.
22. **Quantities:** Director, CRIDA reserves the right to reduce or increase the quantity at the time of placing the Purchase Order as per the revised targets received from Ministry of Agriculture and Farmers' Welfare from time to time.
23. **Jurisdiction:** All disputes including court proceedings shall be settled within the Hyderabad Jurisdiction only.
24. **Rejection of registration:** Conditions not complying with the above are liable to be rejected.
25. The registered farmers will only be considered
26. In the event of the date specified in the document receipt being declared as a closed holiday for purchaser's office, the due date for submission of forms will be the following working day at the specified timings.
27. The registration form should invariably be filled in and duly signed by farmer with identification proof for farmer / land and undertaking.
