## TERMS & CONDITIONS

- All rates are invited per unit basis (which is Per KG/Per Liter/Per m<sup>3</sup> )
  - Certificate of purity of gas is needed for each time, refilling is done along with delivery Challan.
  - The liquid gas is to be supplied at CRIDA Hayatnagar, Research Farm, Vijayawada Highway, Near Deer Park.
  - Unloading of liquid CO<sub>2</sub> into the CRIDA-HRF. CO<sub>2</sub> tank is the responsibility of Rate Contract firm. Adherence due to safety precautions while unloading is the scope of supplier.
  - Weightment of pre and post unloading at a indentified third part weighbridge is to be done by rate contract supplier in the presence of CRIDA stores officer /nominated committee of institute.
  - While submitting quotation the original Gas supplier shall have certified producer of required gas grade.
  - An earnest money of **Rs. 5000/- (Rupees Five thousand only)** should be deposited in the form of Demand Draft / Banker's Cheque in favour of 'ICAR Unit - CRIDA' payable at Hyderabad. The quotation will not be considered if earnest money is not deposited with the tenders.
  - The earnest money would be refunded to all the unsuccessful bidders. For Successful bidders the earnest money would be refunded only after deposition the Security deposit/Performance Guarantee.
  - An amount of Rs.70,000/- as Security Deposit (Performance Guarantee) in the form of DD/ PO/Bank Guarantee/FDR** is to be deposited by the successful Bidder only after receiving a communication from the Institute. In the event of non-deposition of the same within 15 days of the communication, the earnest money will be forfeited. In the event of any default of performance or conditions of supply, the security deposit will be forfeited
  - The last date for submission of quotation is on or before 28-09-2017
  - Quotations should be submitted in a sealed cover addressed to the Director, Central Research Institute for Dry land Agriculture, Santoshnagar, Saidabad Post, Hyderabad - 500 059. The cover containing quotation should invariably be super scribed.

  - The quotation should remain open for acceptance for a period of 90 days from the date (due date)

  - The rates quoted should be net payable for each item for delivery at the Institute at the address given above (inclusive of all goods and services taxes, packing, forwarding, transport, insurance and excluding rebate/discount etc.)
  - Institute GST Registration number is 36AAAJC0416E1ZY.
  - While quoting the rates please mention the following:
    - Approximate time for supply of stores from the date of placing order.
    - Guarantee /Warranty/Expiry period
    - In case you have got any rate contract with the DGS&D, the same may be indicated
    - Any other condition
