INSTRUCTIONS ON SUBMISSION OF BIDS

1. The Tender Acceptance Letter (**Annexure-VI**) & Bid Form (**Annexure-VII**) may be downloaded from the website of /ICAR-CRIDA (www.icar-crida.res.in) free of cost. These documents which form part of the Bid, may be filled-up neatly and submitted in a Sealed Cover.
2. The bidders should submit the bid with proper superscription on the cover as **"QUOTATION FOR UNSERVICEABLE ARTICLES"** and addressed to the Director, ICAR - Central Research Institute for Dryland Agriculture, Santoshnagar, Saidabad PO, Hyderabad - 500059. Bids can be submitted through post/courier or can be deposited in person in the Tender Box kept in Stores Section, ICAR-CRIDA, Hyderabad on/at or before the prescribed due date/time for submission of bids. This office shall not be responsible for any postal delay.
3. The bid should essentially contain the following documents, failing which the same shall be considered non-responsive and summarily rejected:-
 - a) Tender Acceptance Letter duly filled-in, signed and stamped.
 - b) Copy of GST Registration Certificate
 - c) EMD of appropriate amount, by way of demand draft.
 - d) Bid Form, duly filled-in, signed and stamped.
 - e) Copy of Registration Certificate for e-Waste disposal [only for e-Waste bidders]

TERMS AND CONDITIONS

1. The bidder should be registered with GST Department. A copy of GST Registration Certificate should be enclosed along with the bid. The quoted price shall be deemed to be INCLUSIVE OF GST. Based on Invoice issued by this Institute, the successful bidder shall arrange to remit the applicable tax to GST Department and furnish documentary proof of the same to this Institute.
2. The bidders for e-Waste should be registered under the guidelines issued by the Govt. of India, as per E-waste Rules 2016 read with e-waste (Management) Amended Rules 2018. **Valid Registration Certificate shall be produced by such vendors along with their bid, failing which the bid shall be summarily rejected.**
3. **Price for METAL SCRAP (Lot-9) shall be quoted on PER KILOGRAM basis.** Actual weight shall be arrived at electronic weighing bridge by taking unloaded vehicle weight and then the weight of loaded vehicle (same weighing bridge). The charges for the weighment will be borne by the bidder. The computerized weighment receipts are to be mandatorily provided to this institute.
4. The successful bidder of METAL SCRAP shall make a payment of **Rs.1,00,000 (Rupees ONE LAKH only)** by online bank transfer/ Demand Draft drawn on any nationalized bank in favour of **ICAR Unit A/c CRIDA** payable at Hyderabad before lifting the material from Institute premises. An Authorized Official from CRIDA will accompany the loaded vehicle to verify the actual weight of Metal Scrap at weighing bridge. After determination of actual weight, the total cost of METAL SCRAP shall be calculated and the balance amount paid by the bidder to the Institute, on the spot, through digital mode. In case of non-payment of balance amount, the loaded vehicle shall be directed back to the Institute.

5. **Successful bidder of VEHICLES SCRAP (Lot-5) shall arrange cutting of the vehicles into pieces at the Institute premises and hand over to this Institute Nameplates and the cut pieces showing Chassis Number appearing at two/three places on the two-wheelers/four-wheelers.**
6. The bidder can quote for all or one/some of the lots. **The bidder who quotes for all lots shall be given preference over others who quote for lesser number of lots.** The highest bid(s) shall be accepted either as a whole or lot-wise, in a manner whichever is more beneficial to ICAR-CRIDA in public interest.
7. In case any difference in the quoted price in figures and words, the price mentioned in words shall prevail.
8. Bid Security/EMD: The bid should be accompanied by Bid Security/EMD prescribed for the Lots being quoted by the bidder. Bid Security/EMD should be in the form of DD in favour of **"ICAR Unit A/c CRIDA, Hyderabad" payable at Hyderabad.** Bids without EMD shall be summarily rejected. In case Bid-Security amount falls short, the bids for lots quoted by the bidder, in the order of serial number, shall be considered, to the extent the Bid Security covers the bids.
9. In the event of rejection of bids, EMD shall be returned to the bidder, without any interest, unless the same is forfeited.
10. No bid shall be accepted after the due date and time. If the due date is declared a Government Holiday, the bid due date will be next working day at the same time as notified earlier.
11. Bids should be signed by bidder himself/themselves or a person duly authorized on his/their behalf. Bid forms are not transferable.
12. Bidders are advised to inspect the condition of unserviceable items and satisfy themselves before submitting their bids.
13. Overwriting or alterations will also disqualify the bid unless they are legible and attested by bidder/bidders.
14. The quoted Rate/Price shall be valid for acceptance for 30 working days from the date of opening of bid(s).
15. It shall be presumed that the before submitting the bid, the bidder has read carefully all the terms and conditions and accepted the same in full. Any deviation in the terms and conditions is not permitted. Incomplete/conditional bids shall be rejected. No alterations shall be allowed after the bid is submitted. No counter-terms or conditions put forth by bidder shall be accepted.
16. The bids will be opened in presence of the bidders who wish to be present. Only the bidders or their authorized representative possessing authorization letter will be allowed to attend the opening of bids.
17. The bidders are requested to give their full name and address at the time of signing the bid sheet along with contact number for communication. Request for change of name/address shall not be entertained later.
18. All weighing, accounting and loading of material will be done by the bidder/purchaser(s) at their own cost/arrangement.
19. The cost of dismantling/packing/loading/forwarding/transportation or any such charges incurred for lifting goods, shall be borne by the successful bidder at his own cost and risk.
20. The bidder shall be responsible for any damage that may be caused to the Institute property in the process of taking delivery.
21. In the Institute premises, the re-sale of disposed-of items by the successful bidder to another buyer is strictly prohibited.
22. The successful bidder(s) shall make full payment of the quoted amount(s) and lift the concerned goods from Institute premises **within ten working days** from the **date of Award of Contract**, failing which, the bid security shall be forfeited and other actions initiated including re-sale of the goods in question at the risk and cost of the defaulter.

23. In the event of the bidder(s) failing to lift the concerned goods within ten working days from the date of Award of Contract (irrespective of status of payment), **storage charges @ Rs.1000/- per day** (Rupees one thousand only) shall be imposed **on each bidder**, till he/they lift the goods. **No notice shall be issued to the bidder in this regard.**
24. The successful bidder shall obtain Gate Pass from Stores Section before moving the goods out of Institute premises.
25. Loading, handling, labour and transportation shall be the sole responsibility of the purchaser at his own cost, risk and arrangement, only during the prescribed working hours of the Institute. No goods shall be moved out to the Institute on Saturday/Sunday/Holiday.
26. The unserviceable items are being sold on 'AS IS WHERE IS' basis and no guarantee for worthiness of quality can be given by the Institute. The Institute, on behalf of successful bidders, shall provide security to the goods on 'AS IS WHERE IS' basis, to the extent of **ten working days from the date of Award of Contract, including Holidays falling in between, if any.** The Institute is not responsible for deterioration/damage to the goods due to rain or any such climatic condition.
27. Director, ICAR-CRIDA reserves the right to accept or reject any or all the bids as well as to include/modify any of bid conditions stipulated in the tender document. The decision of Director, ICAR-CRIDA shall be final and binding on the bidders. All disputes including court proceedings shall be settled within the **Hyderabad jurisdiction** only.
