#### Background

Climate change is expected to negatively impact agriculture and livelihoods of people dependent on agriculture. The impacts can be negated by adopting smart management techniques developed by the agricultural research and development system in India. Widespread awareness of these practices is essential for enabling the farming community to cope with climate change.

#### **Objectives**

The training programme aims to build the capacity of scientists by giving them exposure to the latest techniques of climate smart agriculture.

#### **Course Content**

The programme will cover climate smart soil management, nutrient management, water management, crops, varieties and cropping systems management, pest and disease management, fodder and livestock management, alternate land use management, integrated farming systems, and location specific climate adaptation and C positive management. It will also cover institutional mechanisms for promoting climate smart agriculture and policy needs and framework for promoting climate smart agriculture, with special emphasis on rainfed agriculture.

#### Eligibility

Scientists & Faculty from ICAR institutes, State Agricultural Universities, KVKs, and R&D Professionals. The applicants must have some understanding of climate change and possess basic computer skills. The maximum number of participants is 20.

#### **Course fee**

Rs 5900 (Rs 5000 + 18% GST) for non-ICAR applicants. There is no course fee for applicants from ICAR.
